



**RESOLUTION 2024-2**

**A RESOLUTION AUTHORIZING AND PERMITTING DISBURSEMENTS FROM THE JOHNSON COUNTY SHERIFF'S COMMISSARY FUND AS ALLOWED BY INDIANA CODE 36-8-10-21.**

WHEAREAS, the Johnson County Council is the fiscal body of Johnson County, Indiana.

WHEAREAS, Indiana Code 36-8-10-21 provides for the establishment of a Commissary Fund into which funds from commissaries at the Johnson County Sheriff's Jail shall be deposited and from which the Sheriff or his/her designee may expend funds for those items enumerated in Indiana Code 36-8-10-21.

WHEAREAS, Indiana Code 36-8-10-21(d)(9) permits expenditures of funds on "items which benefit the Sheriff's Office as are mutually agree upon between the Sheriff and the County Council" and

WHEAREAS, the Johnson County Council and the Johnson County Sheriff's Office mutually agree upon the following disbursements of funds from the Commissary Fund pursuant to Indiana Code § 36-8-10-21, permits the money in said commissary fund to be used as follows, to wit:

1. All statutorily authorized uses;
2. All forms of training and conferences associated with the duties of the Sheriff's Office, including the costs associated with hosting training;
3. Inmate transit costs;
4. Reimbursement for lost or damaged inmate property;
5. Expenses associated with the health and wellbeing of inmates;
6. Expenses associated with the gym maintained by the Sheriff's office utilized by Johnson County Sheriff's Office staff;
7. Postage, including postage for indigent inmates;
8. Shipping cost regarding office equipment or evidence;
9. Expenses associated with investigation call outs or disasters;
10. Supplies or equipment to promote educational activities for inmates;
11. Costs of investigations expenses and special detail expenses (excluding controlled drug buys);
12. Expenses for advertising, marketing, community involvement, recruitment, and sponsorship costs;
13. Expenses associated with professional membership(s) of department personnel;
14. Reimbursement for damaged employee property which is solely related to their employment with the Johnson County Sheriff's Office;
15. Expenses for professional, consulting, and/or legal fees;
16. Expenses associated with legal fees incurred by the Sheriff's Office in their capacity as the Sheriff or employees of the Sheriff's Office;
17. Expenses associated with special events for inmates or employees such as holiday events, retirement events, service award/plaques, recognition events, etc;
18. Expense of software programs specifically used by the Sheriff's Office;
19. Matching funds for grants;
20. Expenses associated with maintenance costs of the Sheriff's Office;

21. Expenses associated with the cost of routine cleaning supplies, office supplies, or any other equipment with running/maintain the day to day operations for the Sheriff's Office;
22. Expenses associated with the communication equipment, computer and network equipment for the Sheriff's Office;
23. Payment or reimbursement for towing and storage for vehicles that may have been erroneously towed/impounded;
24. Expenses associated with the upkeep and maintenance of the Sheriff's Office fleet vehicle;
25. Inadvertent damage that may have occurred to a vehicle (that is not covered by insurance) that was impacted but not the target of criminal enforcement (i.e. flat tire repair/replacement);
26. Expenses associated with photos, videos or digital imagery related to public information and/or outreach programs;
27. Expenses with maintaining the Sheriff's Office SWAT Team, SCUBA Team, Drone Program, Honor Guard, Motorcycle Team, CIRT Team, CIT Program, Bomb Squad, Accident Investigations, and or any other specialty at the Sheriff's Office.

WHEAREAS; the Johnson County Council have determined that it is in the best interest of the County to allow the Johnson County Sheriff's Office to make disbursements from the commissary fund.

NOW, THEREFORE, BE IT RESOLVED BY THE JOHNSON COUNTY COUNCIL THAT;

The monies in the commissary fund of the Johnson County Sheriff's Office may be disbursed to supplement the Office as enumerated in Indiana Code 36-8-10-21 (d)(9) and set forth herein.
