Aspire is beginning to work with Bargersville and it may be beneficial to have a unified or coordinated voice with both Bargersville and Aspire regarding marketing for that area. Commissioner Walls asked if the RDC could utilize some of the FEMA ground as a road. Mr. Gadberry said that he would look into it. There are significant restrictions on what can and cannot be done to those properties.
