2025 Budget Hearings – First & Second Readings – September 3rd, 5th, and 12th, 2024 & Binding Recommendations for Special Taxing Units – September 12th, 2024.

<u>Council Attendance for first day of first reading on September 3rd</u>: Pamela Burton, Ron Deer, Jonathan T. Myers, John Ditmars, John Mallers, and Melinda Griesemer were present.

Mrs. Burton announced John Myers has recently resigned his position with the Council and would not be attending any of the budget hearings.

<u>Council Attendance for second day of first reading on September 5th</u>: Pamela Burton, Ron Deer, Jonathan T. Myers, John Mallers, and Melinda Griesemer were present. John Ditmars was absent.

<u>Council Attendance for second reading & public hearing of binding recommendations on September 12th</u>: Pamela Burton, Ron Deer, Jonathan T. Myers, John Ditmars, John Mallers, and Melinda Griesemer were present.

Presentation from Mike Reuter - Financial Consultant

Mr. Reuter was present to review the updated fiscal plan. He noted the fiscal plan now includes the actual numbers as submitted by the departments for their 2025 budgets. The revenue has been updated to reflect the 2024 actual numbers for the first six months. He stated both the maximum levy and LIT allocation have been certified. The revenues look pretty firm, with the exception of the growth appeal. He then explained in order to give the Council flexibility during the budget hearing process, an additional \$1,000,000 was advertised in the General Fund (in the Council's budget #1001-0135, with no plans to spend), and there is also \$2,012,000 advertised in both the General Fund – Jail (#1001-0124) and in the Jail LIT Fund – Jail (#1233-0124). This was done based on conversations regarding the building of the new Community Corrections Facility. He also stated an additional \$1,000,000 was advertised in the Food & Beverage Fund that could be used for health insurance (#1157-0122).

Secondly, Mr. Reuter reviewed the Six Year Non-Farm Personal Income Growth Factor (which is based on income taxes). This factor limits you on how much you can collect in property taxes (maximum levy) for your operating funds. He explained there were recent legislative changes (in order to limit property tax impacts in 2025) which impacted how this factor is calculated; this was extended another year into 2026. In the past, it was always a straight calculation; now, there is a conditional statement to that. Once you calculate the six year average, you take it times 80% and if that number is more than 4%, then you are limited to 4%. Mr. Reuter noted that about 90% of the units in the state (which includes cities, towns, libraries, townships, etc.), will be limited to the 4%. The County is fortunate enough that it's assessed value (AV) is growing 2% faster than the state on a three year average, which qualifies the County for an appeal. He explained this is a high bar to reach now, noting a unit would have to grow 11%; if you grow 10.5%, then you only get the 4%; if you don't grow at all, you still get the 4%. This has created inequities across the state and he anticipates there will be more conversations about unique identifiers within a community. This new approach may not necessarily be a bad thing for the County. It might not be as much as we get from an appeal right now, but it might not be bad because right now we have to appeal to get it; we have to mathematically qualify for it and

write a story about why we need this appeal. This new approach might be an automatic thing, based on what is happening in Johnson County, not what is happening on a state-wide average.

Right now, the County's AV has grown 11.7%, which qualifies for an appeal. He anticipates the County will qualify for an appeal for at least the next two years. Last year, the County had a little struggle getting the appeal approved. After receiving the DLGF's decision of a partial approval, we appealed their decision in person and we received a revised order approving the full amount. This year's appeal amount is very similar to last year's. He and Adam Gadberry, County Attorney, are going to spend more time on the narrative with the appeal application. With all this being said, he explained the fiscal plan he has prepared reflects the assumption the appeal has been approved for the next two years.

Next, Mr. Reuter talked about the Local Option Income Tax (LIT). This figure came in stronger than what he projected, whereas he is conservative on his figures. The last known collection year was 2022; the new certified number for 2025 is \$65,229,163, which is an increase of 10.3%. He stated that is good growth and reminded the Council members that if the State has a balance of anything over 15%, then a special distribution would be done. He anticipates \$9,166,255 in special distributions over the next few years. He noted the special distributions are included in his numbers in the fiscal plan. He then pointed out that the County's share of the certified shares has decreased slightly the past few years due to the other units' levy within the county have increased faster than the County's. If we did not get the appeal approved, the County would have seen a larger percentage decrease. LIT is allocated based on what you're collecting in property tax, less new debt, plus the prior year distribution. With the County getting the appeal approved, it kept our levy up and our percentage up for the LIT allocation.

Mr. Reuter then briefly reviewed the following funds:

- General Fund This fund shows a structural deficit for 2025 of \$2,654,171. However, it is actually in balance because he has plugged in numbers under Capital Outlays for road projects, which is not being spent yet. This is being built up, \$4 million annually, but not being spent yet (\$12 million total for 2025). This may start being spent in 2025 against some bonding. He also noted he only estimated 80% of the interest revenue, anticipating the interest rates to be cut (under Misc Revenue). Additionally, he noted the LIT special distribution and the growth appeal previously discussed. Overall, this fund is in a really good cash position, with a cash balance of \$43,391,352 at the end of 2025.
- **Property Reassessment** As the budget is currently submitted, it is out of balance by \$355,838, but this can be easily absorbed by the cash balance currently in this fund. He noticed a few positions have been moved from this fund to the General Fund, which is a good idea.
- Animal Shelter This budget has its own rate and levy, but it does share part of the maximum levy which
 affects the General Fund. He usually plugs in enough levy to balance this fund, and leave it with sufficient
 cash.
- Rainy Day This fund has a \$3,510,950 cash balance. Mr. Reuter stated more dollars could be moved from the General Fund to this fund if the Council so chooses; however, at this point he is not recommending this at this time because of the growth appeal. This may be something that can be looked at some time after January.
- **Highway** This fund is showing out of balance by \$378,065; however, it has sufficient cash to cover that. The cash balance at the end of 2025 is estimated to be \$3,450,874.
- Local Road & Street This budget is in balance and has a cash balance of \$1,974,263.

- **Health** This fund is similar to Animal Shelter, as far as sharing the maximum levy with the General Fund. The budget is in balance and has a really good, strong cash balance. This fund is estimated to have a cash balance of \$1,420,130 at the end of 2025; noting it really only needs about \$600,000 (based on maintaining a 50% cash balance of the next year's property tax collections in the fund).
- Cumulative Capital Development (CCD) This fund is in balance by \$836,130 and the cash balance at the end of 2025 shows \$6,008,258.
- Bond 3 Currently in the process of replacing this bond; anticipating on keeping the same tax rate
- LIT Fund (Jail Costs) This budget is showing out of balance right now by \$1,596,502, and with the
 possibility of building a new Community Corrections Facility, he suggests moving some expenses back to the
 General Fund, which would help balance this fund. This will also allow the debt payment to be paid from this
 fund.
- Statewide E911 This budget is out of balance by \$488,811. There are more expenditures than revenue; he suggests moving expenses to the General Fund or Food & Beverage in 2026 due to the structural deficit.
- **EDIT Tax** This budget is showing out of balance by \$9,062,064 by design; the appropriation is for road projects, and the money won't be spent yet.
- Food & Beverage This budget is currently in balance by \$292,099. This fund will have a cash balance of \$3,181,861 at the end of 2025; it receives revenue monthly.
- Combined General Fund, EDIT, and Food & Beverage These budgets together are showing out of balance by \$11,424,136; however, \$12,000,000 in the General Fund and \$15,000,000 in the EDIT Fund are earmarked for future road projects.

Lastly, Mr. Reuter reviewed the tax rates; it is modeled to remain flat. In summary, everything looks good. The only factors to keep an eye on are the interest rates, legislative changes, and the status of the appeal.

The Council members thanked Mr. Reuter for his time and information.

The Council then started reviewing the individual budgets.
