# DR- 3460-21 MEADOWS @ BELLEVIEW SECTION TWO MAJOR - FINAL

Bob Staton of Banning Engineers presented tehpetition. Mr. Staton stated Meadows @ Bellview Section Two has met the Subdivisipn Control Ordinance requirements Requesting a final approval.

Richard Hoover Johnson County Planning and Zoning presented review with letter dated July 6, 2021

Mr Hoover stated the overall proposed project is a 197 lot major subdivision pn 90.9 acres, the preliminary design was approved on February 4, 2020.

Mr. Hoover explained the discharges of two basins of acreage. Discharge rates from the entire site is being restricted to the pre-developed 2 year rates (2- 10 year) now discharging at the northwest corner.

Mr Hoover stated the information on discharge rates requirements used for this site.

A proposed detention pond will outlet into Honey Creek by connections to an existing 36" RCP that is part of adjoining and previously approved Riley Meadows Subdivision.

Mr. Hoover stated Section two consists of the development of 62 lots on 20.9 acres in the southern portion of the site

Mr. Hoover recommends approval as presented.
