W-8-21; Sarah and Anthony Asher – Waiver Request. 10 acre parcel adjacent to 1608 S. 575 W.

Petitioners Anthony and Sarah Asher (1847 N. Main St., Franklin 46131) were present to speak and address concerns.

 - A. The line is representing the creek or stream.
- Q. Board member Charlie Canary asked how of the flood plain is in what they are wanting to do?

- A. Staff referred to the overhead image an illustrated what areas they could build in.
- Q. Board member Nathan Bush asked the Petitioners for confirmation that the flood zone would not bother their purposed building project?
 - A. Petitioners responded that they had contacted both the county and state engineers who both felt that as long as they built in accordance to the flood elevation that it would not be an issue.
