# SOUTH CENTRAL SOCCER CLUB: Requesting Use of County Property Located at Morgantown Road and State Road 144 from October 21st thru October 23rd

1. Ordinance 2022-O-23: An Ordinance of the Johnson County Board of Commissioners Amending Title 25 Article 6: Tattoo Parlors: Body Piercing – First Reading

Betsy Swearingen, Director, appeared before the Commissioners to request Johnson County's regulations of tattoo parlors and body piercing locations be updated to better protect the health and safety of Johnson County citizens via Ordinance 2022-O-23.

Mr. Walls made a motion to approve the request as presented on first reading. Mr. West seconded the motion, which carried unanimously.

## 1. Approval of 2022 Johnson County Trick-or-Treating Hours

### E. Highway

## 1. Approval and Execution of Preliminary Engineering and R/W Services Contract for the CR 144 and Morgantown Road Intersection Project

Luke Mastin, Supervisor, appeared before the Commissioners to request approval of a contract for CR 144 and Morgantown Road Intersection Project with Crossroad Engineers. This project will consist of construction of a roundabout to replace the current angled 4-way stop intersection. Mr. Mastin said this is a first priority project that will be funded by Johnson County and the Town of Bargersville with Impact Fee revenue.

Mr. Walls made a motion to approve the request pending legal review. Mr. West seconded the motion, which carried unanimously.

## 2. Approval and Execution of the 2022 Preservative and Rejuvenating Seal Program Contract

Mr. Mastin stayed before the Commissioners to request approval of a contract with RejuvTec for the 2022 Pavement Rejuvenation Program. He said RejuvTec is the single source supplier for the Reclamite and CRF products; this contract will be awarded under the Special Purchasing Provision.

Mr. West made a motion to approve the request pending legal review. Mr. Walls seconded the motion, which carried unanimously.

# 3. Approval of INDOT-LPA Funding Agreement for Bridge 66 Rehabilitation Project

Mr. Mastin's final request was for approval of the Bridge 66 Rehabilitation Project. This project was awarded \$647,000 of federal funding for the construction and inspection phases in fiscal year 2025.

Mr. Walls made a motion to approve the request as presented. Mr. West seconded the motion, which carried unanimously.
