

**COUNTY COUNCIL ADOPTION OF SPECIAL TAXING (BINDING) UNITS'**  
**BUDGETS - OCTOBER 17, 2022 (5:00pm)**

The meeting was called to order by President, Jim Ison. The following members were present: Jonathan T. Myers, Rob Henderson, John Myers and Ron Deer. Pete Ketchum was present via zoom; Melinda Griesemer was absent.

Mr. Ison noted the purpose of this Special Meeting of the Council was to adopt the budgets of the Special Taxing Units that were presented, and approved at the public hearing on September 15, 2022.

**Solid Waste District**

Jessie Biggerman, Director, and Pat Sherman, Financial Advisor, were present in the audience to answer any questions the Council may have had regarding the adoption of this 2023 budget.

Mr. Deer moved to approve the budget of \$1,079,860, levy of \$626,607, and rate of \$0.0061 as presented. Mr. Jonathan T. Myers seconded the motion, which carried 6-0.

**Hants Lake Conservancy**

Mr. Deer made a motion to approve the budget of \$15,650, levy of \$12,369, and rate of \$0.1957 as presented. Mr. Henderson seconded the motion, which carried 6-0.

**Amity Fire District**

Janet Alexander, Financial Advisor, was present in the audience to answer any questions the Council may have had regarding the adoption of this 2023 budget.

Mr. Deer made a motion to approve the total budget of \$254,500, the total levy of \$151,950, and the total rate of \$0.1090, as requested. Mr. Jonathan T. Myers seconded the motion that carried 6-0.

**Hensley Fire District**

Jeff Peters, Financial Advisor, was present in the audience to answer any questions the Council may have had regarding the adoption of this 2023 budget.

Mr. Deer made a motion to approve the total budget of \$842,911, the total levy of \$713,503, and the total rate of \$0.1729, as requested. Mr. Jonathan T. Myers seconded the motion that carried 6-0.

**Needham Fire District**

Mr. Peters was also present in the audience to answer any questions the Council may have had regarding the adoption of this 2023 budget.

Mr. Jonathan T. Myers made a motion to approve the total budget of \$562,048, the total levy of \$477,220, and the total rate of \$0.1424, as requested. Mr. Deer seconded the motion, which carried 6-0.

**Nineveh Fire District**

Sandy Beatty, Financial Consultant, was present in the audience to answer any questions the Council may have had regarding the adoption of this 2023 budget.

Mr. Jonathan T. Myers made a motion to approve the total budget of \$556,000, the total levy of \$376,761, and the total rate of \$0.1460, as requested. Mr. John Myers seconded the motion, which carried 6-0.

### Bargersville Fire District

Bargersville Fire Chief, Eric Funkhouser, and Financial Advisor, Jerry Hickman, were present in the audience to answer any questions the Council may have had regarding the adoption of this 2023 budget.

Mr. Ison read aloud Resolution 2022-02: *A Resolution to Appeal for an Increase above the Maximum Levy; Appeal Type: Three-year Growth Factor in the amount of \$90,456 for Bargersville Fire Protection District.*

Mr. Deer made a motion to approve Resolution 2022-02 as presented. Mr. John Myers seconded the motion, which carried 6-0.

Mr. Deer then made a motion to approve the total budget of \$10,493,857, the total levy of \$6,875,915, and the total rate of \$.4515, as requested. Mr. Jonathan T. Myers seconded the motion, which carried 6-0.

### White River Fire District

Jeremy Pell, White River Fire Department Chief, Ben Roeger, Accountant, and Mike Hoffman, Community Liaison, were all present in the audience to answer any questions the Council may have had regarding the adoption of this 2023 budget.

Mr. Deer made a motion to approve the total budget of \$16,252,895, the total levy of \$9,714,025, and the total rate of \$.4161, as requested. Mr. John Myers seconded the motion, which carried 6-0.

### **Adjournment**


There being no further business, Mr. Jonathan T. Myers moved to adjourn the meeting. Mr. John Myers seconded the motion; the motion carried 6-0.




