2023 Budget Hearings – First & Second Readings – September 6th, 8th, and 15th, 2022 & Binding Recommendations for Special Taxing Units – September 15th, 2022

<u>Council Attendance for first day of first reading on September 6th</u>: Jim Ison, Melinda Griesemer, Pete Ketchum, Jonathan T. Myers, Rob Henderson, John Myers, and Ron Deer.

<u>Council Attendance for second day of first reading on September 8th</u>: Jim Ison, Melinda Griesemer, Pete Ketchum, Rob Henderson, John Myers, and Ron Deer. Jonathan T. Myers was absent.

<u>Council Attendance for second reading & public hearing of Non-binding & binding recommendations on September 15th</u>: Jim Ison, Melinda Griesemer, Pete Ketchum, Jonathan T. Myers, John Myers, and Ron Deer. Rob Henderson was absent.

Presentation from Mike Reuter - Financial Consultant

Mr. Reuter was present to review the updated fiscal plan. He noted the fiscal plan now includes the actual numbers as submitted by the departments for their 2023 budgets. The revenue has been updated to reflect the 2022 actual collections for the first six-months, and he has revised some of the estimates for the last six-months of the year. He stated the amounts in the fiscal plan are less than the advertised amounts (General Fund was advertised \$2,000,000 higher & the Food & Beverage Fund was advertised \$1,000,000 higher) to give the Council some flexibility during the budget process. He also noted an additional \$5,500,000 was advertised in the Jail LIT Fund (and this does not show in the fiscal plan), in case the Council chooses to move expenses, other than the bond payment, to this fund.

Secondly, Mr. Reuter reviewed the Six-Year Non-Farm Personal Income Growth Factor (which is based on income taxes). He noted in May, he had forecasted this being a 4% increase and the certified number was a 5% increase.

Mr. Reuter then stated the certified net assessed value (CNAV) came in very strong with a 20.58% increase, noting this is a really strong increase. He also voiced this increase in CNAV will allow the County to file a growth appeal. If the CNAV grows faster than 2% of what the State is growing, then an appeal for a higher levy can be filed.

Next, Mr. Reuter shared some hopeful news for the Local Income Tax (LIT). The fund came in with an increase of 4.1%. He reflected on last year's decrease in this fund and the reasoning behind the decrease. He explained that during the pandemic last year, the Governor issued an executive order to delay the income tax filing date from April 15th to July 15th. The LIT distribution is based on a July 1 – June 30th fiscal year timeframe. The Governor then issued another executive order that extended the filing deadline for another two months. Therefore, the distribution for 2021 included two extra months; and now, the distribution for 2022 was only for ten months (September – June). In 2023, it is back to the normal twelve months.

Mr. Reuter then briefly reviewed the following funds:

- **General Fund** This fund currently shows it is out of balance by \$1,729,379. However, as you go through the budget process, this number will be brought more back in balance. There is strong sufficient cash in this fund, so the budget could be approved with no changes. He noted he has plugged in a Special LIT distribution of \$715,000 (the official number won't be released until around March 2023).
- **Property Reassessment** As the budget is currently submitted, it is out of balance by \$300,259, but the cash balance in this fund can easily absorb this.
- **Animal Shelter** This budget has its own rate and levy, but it does share part of the maximum levy with the General Fund. He plugs in enough levy to balance this fund, and leave it with sufficient cash.
- Rainy Day This fund has a \$6,510,950 cash balance. Mr. Reuter stated incre dollars could be moved from the General Fund to this fund if the Council so chooses; up to 15% of the General Funds' cash can be transferred up through 2024.
- **Highway** This fund is trending to be in balance with the budget for 2023 as it has been in the previous years; this could be because he is using a little higher revenue amount for the Wheel/Surtax.
- Local Road & Street This budget is in balance; there should be no problems approving it.
- **Cumulative Bridge** This is a rate driven fund (and shares the maximum levy with the General Fund); and since rates are affected by the CNAV, the levy has increased in this budget. He noted the rate is now drawing more money from the General Fund than in previous years.
- **Health** This fund is similar to Animal Shelter, as far as sharing the maximum levy with the General Fund. This fund has a good cash balance of \$854,600.
- Cumulative Capital Development (CCD) This is a rate driven fund. With the higher CNAV, it has pulled additional dollars. The budget for 2023 is in balance by \$612,720 and the cash balance at the end of 2023 shows \$5,237,475. This fund does not affect the General Fund.
- GO Bond There was a GO Bond issued with the intent to pay it back over the normal 2 year timeline; however, there is the option to pay the whole bond payment in 2023 and retain the same tax rate as the previous year. With the increases in assessed value, keeping the same tax rate may help with the burden of taxes on taxpayers in the upcoming year.
- LIT Fund (Jail Costs) This fund shows a budget with the debt payment of \$5,515,750, and an additional advertised amount of \$5,555,555 for any additional personnel costs. This fund will have sufficient cash balance to cover this.
- **Statewide E911** This budget is out of balance by approximately \$160,000, but has a sufficient cash balance of \$1,187,386 to cover it.
- **LIT Economic Development** This budget is submitted with the advertised amount of \$4,423,802 only.
- Food & Beverage This budget is currently out of balance by \$82,688. There is plenty of cash to cover, noting the revenue is received monthly.

Lastly, Mr. Reuter reviewed the tax rates. He is forecasting a slight increase in the Capital Bond Fund (from 0.0381 to 0.0642) to maintain a flat tax rate (an overall tax rate of 0.3012).

The Council members thanked Mr. Reuter for his time and information.

Mr. Ison stated they need to add Fund #1112 - LIT Economic Development to the end of the agenda.

Mr. John Myers moved to approve the addition to the agenda. Mr. Jonathan T. Myers seconded the motion, which carried unanimously.

Before the actual hearing began for all of the budgets, the Council members held a discussion regarding the intent of how the salary increases were to be calculated after reviewing the salary study data. Most budgets were submitted with four-percent (4%) increase per the budget guidelines. It was agreed upon to move forward with the budgets as submitted for first reading, then recalculate the salaries with a formula to increase salaries to one-half the difference of the external midpoint of the salary study plus the four-percent (4%) increase for the second reading.

Ms. Griesemer made a motion to give all employee salaries below the external midpoint of the salary study a raise to one-half the external midpoint plus the four-percent (4%) increase and to give all employees above the external midpoint a four-percent (4%) raise. Mr. Ketchum seconded the motion, which carried unanimously.

At the beginning of the second day of the first reading, the Council members discussed creating a ceiling for the amount an employee could receive as a raise with the external midpoint-average formula.

Mr. Henderson made a motion to place a five-thousand dollar (\$5000) ceiling prior to the additional four-percent (4%) increase for any given salary. Mr. John Myers seconded the motion that carried 5-1; Mr. Deer voted nay.
