

**COUNTY COUNCIL SPECIAL MEETING: ADOPTION OF SPECIAL TAXING
(BINDING) UNITS' BUDGETS - OCTOBER 9, 2023 (5:00pm)**

The meeting was called to order by President, Jonathan T. Myers. The following members were present: Pamela Burton, John Mallers, Ron Deer, John Myers and John Ditmars. Melinda Griesemer was absent.

Solid Waste District

Mr. Deer moved to approve the total budget of \$1,315,503, the total levy of \$1,251,671, and the total rate of \$0.0143 as presented. Mr. John Myers seconded the motion, which carried 6-0.

Approval of Resolution 2023-05: A Resolution of Petition to Appeal for an Increase above the Maximum Levy (Appeal Type: Three-year Growth Factor in the amount of \$100,000 for Solid Waste District)

Jeff Peters, financial consultant, was present to answer any questions the Council may have regarding this resolution.

Mr. Deer made a motion to approve Resolution 2023-05 as presented. Mr. Mallers seconded the motion, which carried 6-0.

Hants Lake Conservancy

Mr. Deer made a motion to approve the total budget of \$15,650, the total levy of \$12,400, and the total rate of \$0.2309 as presented. Mr. John Myers seconded the motion, which carried 6-0.

Amity Fire District

Mr. Deer made a motion to approve the total budget of \$453,475, total levy of \$268,464, and the total rate of \$0.2410 as presented. Mr. John Myers seconded the motion that carried 6-0.

Hensley Fire District

Mr. Peters was also present in the audience to answer any questions the Council may have regarding the adoption of this 2024 budget.

Mr. Deer made a motion to approve the total budget of \$1,098,226, the total levy of \$741,291, and the total rate of \$0.1733 as presented. Mr. John Myers seconded the motion that carried 6-0.

Needham Fire District

Mr. Peters was also present in the audience to answer any questions the Council may have regarding the adoption of this 2024 budget.

Mr. Deer made a motion to approve the total budget of \$1,177,983, the total levy of \$493,843, and the total rate of \$0.1452 as presented. Mr. Deer seconded the motion, which carried 6-0.

Nineveh Fire District

Mr. Deer made a motion to approve the total budget of \$589,000, the total levy of \$400,843, and the total rate of \$0.1712 as presented. Mr. John Myers seconded the motion, which carried 6-0.

Bargersville Fire District

Bargersville Fire Chief, Eric Funkhouser was present in the audience to answer any questions the Council may have regarding the adoption of this 2024 budget.

Mr. Deer made a motion to approve the total budget of \$12,541,261, the total levy of \$7,592,552, and the total rate of \$0.4781 as presented. Mr. John Myers seconded the motion, which carried 6-0.

Approval of Resolution 2023-06: A Resolution of Petition to Appeal for an Increase above the Maximum Levy (Appeal Type: Three-year Growth Factor in the amount of \$564,006 for Bargersville Fire Protection District)

Mrs. Burton made a motion to approve Resolution 2023-06 as presented. Mr. John Myers seconded the motion, which carried 6-0.


White River Fire District




