# 2024 Budget Hearings – First & Second Readings – September 5<sup>th</sup>, 7<sup>th</sup>, and 14<sup>th</sup>, 2023 & Binding Recommendations for Special Taxing Units – September 14<sup>th</sup>, 2023.

<u>Council Attendance for first day of first reading on September 5th</u>: Jonathan T. Myers, John Myers, John Ditmars, John Mallers, Pamela J. Burton, Melinda Griesemer, and Ron Deer were present.

<u>Council Attendance for second day of first reading on September 7th</u>: Jonathan T. Myers. John Myers, John Ditmars, John Mallers, Pamela J. Burton, Melinda Griesemer, and Ron Deer were present.

Council Attendance for second reading & public hearing of binding recommendations on September 14th: Jonathan T. Myers, John Myers, John Ditmars, John Mallers, Pamela J. Burton, and Ron Deer were present. Melinda Griesemer was absent. Mr. Mallers left around noon for the day and was not present for the binding recommendations.

#### Presentation from Mike Reuter – Financial Consultant

Mr. Reuter was present to review the updated fiscal plan. He noted the fiscal plan now includes the actual numbers as submitted by the departments for their 2024 budgets. The revenue has been updated to reflect the 2024 actual numbers for the first six-months. He stated the amounts in the fiscal plan are less than the advertised amounts (General Fund was advertised \$1,000,000 higher and the Food & Beverage Fund was advertised \$500,000 higher) to give the Council some flexibility during the budget process. He also noted an additional \$500,000 was advertised in the LIT Correctional/Rehab Facility Fund (Jail LIT Fund; and this does show in the fiscal plan), in case the Council chooses to move expenses, other than the bond payment, to this fund.

Secondly, Mr. Reuter reviewed the Six Year Non-Farm Personal Income Growth Factor (which is based on income taxes). This factor limits you on how much you can collect in property taxes for your operating funds. He explained there were recent legislative changes (in order to limit property tax impacts in 2024) which impacted how this factor is calculated. In the past, it was always a straight calculation; now, there is a conditional statement to that. Once you calculate the six year average, you take it times 80% and if that number is more than 4%, then you are limited to 4%. Mr. Reuter noted that about 90% of the units in the state (which includes cities, towns, libraries, townships, etc.), will be limited to the 4%. However, the County will qualify for an appeal that goes along with that. To qualify for an appeal, your assessed valuation (AV) has to grow 2% faster than the state on a three year average. The County's AV has averaged growth of about 1.250%, whereas the state has averaged growth of only .80%. He then emphasized just because an appeal is filed, does not mean it will be approved. Last year the County filed an appeal and received \$388,550; based on the calculation this time, the amount for the appeal would be \$1,653,000, which is a substantial increase and more questions would be asked; he expressed some concern about the full amount of the appeal won't be awarded. To file the appeal, the Council will need to approve a resolution and he would work with the Auditor's office to get it submitted to the Department of Local Government Finance by October 19th.

Next, Mr. Reuter talked about the Local Option Income Tax (LIT). This figure came in stronger than what he projected, whereas he is conservative on his figures. The last known collection year was 2021;

the new certified number for 2024 is \$59,152,959, which is an increase of 6.3% (assuming the 2022 base is correct; this number won't be known until the spring). He stated that is good growth and reminded the Council members that if the State has a balance of anything over 15%, then a special distribution would be done in May of 2024 (his assumption is the County would receive \$2,915,119). Mr. Reuter stated he has assumed this number is correct and it is reflected in his fiscal plan.

#### Mr. Reuter then briefly reviewed the following funds:

- General Fund This fund currently shows it is out of balance by \$150,398. However, it is actually in balance because he has plugged in numbers under Capital Outlays for road projects, which is not being spent yet. If this was removed, the fund would be in balance more than \$4 million. He also noted the interest amount (under Misc Revenue) is up substantially; he estimated interest at \$5.3 million, but this could change based on the interest rates and the economy. Additionally, he noted the LIT special distribution and the growth appeal previously discussed. Overall, this fund has a strong cash balance.
- **Property Reassessment** As the budget is currently submitted, it is out of balance by \$452,624, but this can be easily absorbed by the cash balance currently in this fund. At some point, the revenue and expenditures need to be realigned because more is being spent from this fund than it is receiving.
- Animal Shelter This budget has its own rate and levy, but it does share part of the maximum levy which affects the General Fund. He usually plugs in enough levy to balance this fund, and leave it with sufficient cash; however, the expenses have increased so he will need to plug in more levy for this fund to increase the cash balance.
- Rainy Day This fund has a \$6,510,950 cash balance. Mr. Reuter stated more dollars could be moved from the General Fund to this fund if the Council so chooses; however, at this point he is not recommending this at this time because of the growth appeal. This may be something that can be looked at some time after January.
- **Highway** This fund is showing out of balance by \$599,998; however, it has sufficient cash to cover that. The cash balance at the end of 2024 is estimated to be \$3,036,675.
- Local Road & Street This budget is in balance and has a cash balance of \$1,681,693.
- Cumulative Bridge This is a rate driven fund (and shares the maximum levy with the General Fund); and since rates are affected by the CNAV, the levy has increased in this budget. He noted the rate is now drawing more money from the General Fund than the previous years.
- **Health** This fund is similar to Animal Shelter, as far as sharing the maximum levy with the General Fund. The budget is in balance. This fund is estimated to have a good cash balance of \$1,296,758 at the end of 2024; noting it really only needs about \$600,000 (based on maintaining a 50% cash balance of the next year's property tax collections in the fund).
- Cumulative Capital Development (CCD) This fund is in balance by \$525,831 and the cash balance at the end of 2024 shows \$4,927,227.
- LIT Fund (Jail Costs) This budget is showing out of balance right now by \$1,176,500, but there is a strong cash balance to absorb that. He noted that in 2024 there are two debt payments due, and in 2025, there is only one debt payment due.
- Statewide E911 This budget is out of balance by \$607,239. The revenue from the State has slightly decreased and he is unaware of any other revenue going into this fund. At some point, some expenses may need to be moved to the General Fund.
- **EDIT Tax** This budget is showing out of balance by \$4,014,772; however, the appropriation is for road projects, and the money won't be spent yet.
- Food & Beverage This budget is currently in balance by \$119,432. This fund will have a cash balance of \$2,250,390 at the end of 2024; it receives revenue monthly.

• Combined General Fund, EDIT, and Food & Beverage - These budgets together are showing out of balance by \$4,045,737; however, \$8,000,000 is earmarked for future road projects.

Lastly, Mr. Reuter reviewed the tax rates. A new General Obligation Bond will be done by the end of the year; it will be sized to the AV once it gets certified in order to maintain a flat tax rate.

The Council members thanked Mr. Reuter for his time and information.

At the beginning of the second day of the first reading, Mr. Jonathan T. Myers requested Kierstin Larson, Deputy Auditor, present information regarding the data provided in the County Fact Book from the Association of Indiana Counties.

Mrs. Larson briefly reviewed the information included in the Fact Book and how Johnson County's salaries ranked among the 20 Indiana Counties that are closest in population to Johnson County.

Mr. John Myers then suggested a 6% salary increase across the board with the exception of a 7% salary increase for merit deputies and correctional officers and a 5% salary increase for Elected Officials, as well as attempt to correct certain parodies in salaries within certain departments.

Brief discussion was held regarding the timeline to receive information from Mr. Reuter and the best process to analyze all information prior to the budget hearings in future years.

At the end of the second day of the first reading, a brief discussion was held regarding the process to analyze different raise percentages in a fiscal plan prior to the second reading.

Mr. Deer suggested a 5% increase for Elected Officials, a 7% increase for all other employees with the exception of the public safety positions, which he suggested should be approved as presented.

The Council came to the consensus to analyze the budget at a 6%, 6.5%, and 7% salary increase for all departments prior to the second reading of the budgets.
