You must have a computer with a mouse to sign the deduction application.

**NOTE: IF YOU HAVE RE-FINANCED YOUR MORTGAGE, YOU MOST LIKELY WILL NOT HAVE TO RE-FILE THE HOMESTEAD DEDUCTION. PLEASE FEEL FREE TO GIVE US A CALL TO CHECK THIS FOR YOU. THE ONLY TIME A HOMESTEAD DEDUCTION NEEDS TO BE RE-FILED IS WHEN THE ACTUAL DEED TO THE PROPERTY HAS BEEN CHANGED.

Things to Remember When Filing Your Deduction

If you are filing a Homestead Deduction, you will need to include the last FIVE digits of your social security number. If you have a spouse, you will need to include this information for them as well, even if they are not on the deed to the property.

If you have re-financed your mortgage, you most likely will not have to re-file the Homestead Deduction. Please feel free to give us a call to check this for you. The only time a Homestead Deduction needs to be re-filed is when the actual deed to the property has been changed.

We are able to access your recorded documents and will fill in any missing or incorrect information as needed after you have submitted you application to us.
