## COUNTY COUNCIL REGULAR MEETING – JUNE 10, 2024

The meeting was called to order by Vice President, John Mallers.

#### A. Call the Meeting to Order

#### 1. Roll Call

The following members were present: Ron Deer, John Myers, Jonathan T. Myers, John Mallers, and Melinda Griesemer. Pamela Burton was present via Zoom. John Ditmars was absent.

#### 2. Invocation

Ms. Griesemer gave the invocation.

## 3. Pledge of Allegiance

Mrs. Burton led the Pledge of Allegiance.

# 4. Approval of the 6/10/2024 Agenda:

Mr. Mallers noted there was a revision to the Health Department's transfer request on item 6a of the Consent Agenda.

Betsy Swearingen, Director of Health, stated her department ordered promotional materials; however, they were not approved by the State as they normally have been in the past.

All votes were taken in a roll call format.

Ms. Griesemer made a motion to approve the agenda as amended. Mr. John Myers seconded the motion, which carried 6-0.

#### 5. Public Comments (5 minute time limit)

Ms. Griesemer recognized the  $80^{th}$  Anniversary of Dooms Day that was on June  $6^{th}$  and gave a brief history of the event.

B. Approval of Ordinance 2024-05 (First Reading): An Ordinance of the Johnson County Council Authorizing the Issuance of Local Income Tax Revenue Bonds (with Property Tax Pledge) for the Purpose of Providing Funds to Acquire, Construct, Install, Rehabilitate, and Equip Certain Correctional Facilities and Rehabilitation Facilities and to Pay Incidental Expenses in Connection Therewith and on Account of the Issuance of the Bonds

Jeff Peters, Peters Franklin Financial Advisor, was present to explain the bond process. The total amount of the project is estimated to be about \$38.4 million; however, some cash reserve will be used, so the actual amount of the bond will be less. He then explained the current revenue stream that would get this bond repaid in approximately 10 years and why it is being structured this way.

Kevin Walls, Commissioner, was also present in the audience for this request.

Adam Gadberry, County Attorney, noted that this is the first reading, and the Council has time to decide the funding sources and final bond amount prior to the second reading.

A brief discussion was held regarding funding sources and the current bond market.

Mr. Jonathan T. Myers moved to approve the first reading of Ordinance 2024-05 as presented. Mr. John Myers seconded the motion, which carried 6-0.

He noted this position is hard to fill and having someone with experience and familiarity with the fleet is an asset.

Next, Mr. Mastin then explained items 5c and 6a are both requests to appropriate additional funding to purchase trucks and equipment. Lastly, he added 5d is for services to install a new intersection alert system.

A brief discussion was held regarding the timing of the change and the structure of the positions.

Ms. Griesemer made a motion to approve the requests as presented. Mr. Deer seconded the motion, which carried 4-2; Mr. Jonathan T. Myers and Mr. Mallers both voted nay.
